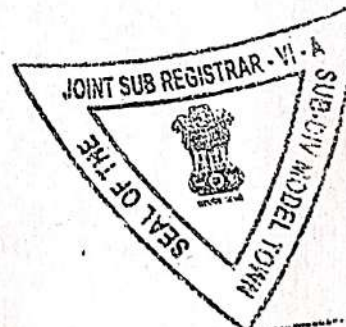

2. The name of the Trust shall be "Maa Saraswati Educational & Charitable Trust". The name may be changed by unanimous consent of all the trustees.
3. The principal office of the Trust shall be situated at ND-60, First Floor, Pitampura, Delhi-110034 or such other place as may from time to time be decided by unanimous consent of all the trustees.
4. Activities of the Trust shall be throughout India and abroad.






Provided that such Rules and Regulations shall not be repugnant to the provisions hereof or offend the objects or purposes of the trust or be inconsistent therein.


